 - I fully understand and acknowledge that these risks and dangers may be caused by the negligence of the owners, employees, officers or agents of **The Bounce Palace**, the negligence of the participants, the negligence of others, or by accidents, breaches of contract, the forces of nature, or other causes; and
 - I fully understand and acknowledge that by my participation in these rides, activities and/or use of apparatus, I hereby assume all risks and dangers and all responsibility for any losses and/or damages whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers, employees of **The Bounce Palace**, or by any other person.
 - I fully understand and acknowledge, for myself, my heirs and/or assigns, that by participating in this ride, activity, and/or apparatus, I am stating that I do not have **any** physical and/or mental condition, which would affect my ability to participate in this ride, activity, and/or apparatus, including but not limited to the following: back problems, heart conditions, pregnancy, epilepsy, motion sickness;
 - I hereby expressly state that I am not under the influence of drugs/alcohol or any ailment that can be aggravated by the use of this ride, activity, and/or apparatus;
 - I knowingly, freely, and expressly assume any and all risks of injury, both known and unknown, associated with participation in the provided ride, activities, and/or apparatus, even if arising from the negligence of persons released from liability below;
 - I knowingly and freely assume full responsibility for my participation and the participation of all persons listed on Page 2 in the use and enjoyment of the ride, activity, and/or apparatus;
 - I knowingly understand this ride, activity, and/or apparatus, and any others provided, can be physically intense and usually results in the participant falling. I understand the rules of play and will comply with all rules and regulations. If I observe any unusual or unnecessary hazard during my participation, I will bring such to the attention of the nearest official as soon as is practical;
